

## COURSE HISTORY

Hidden Valley Golf Club has been in business since 1962 with the original nine holes on the west side of the property, eight of these holes are still in use today. Since then Hidden Valley has undergone numerous changes. The second nine hole course was added in 1972 to create the first eighteen hole design. Twenty years later Hidden Valley became a twenty-seven hole facility when a third nine was added on the east side of the property. The course existed as twenty-seven holes until October of 2004 when the facility was sold to a group of investors. At that time the course was redesigned to an eighteen hole layout. The new layout will play at just over 6200 yards from the back tees with a par of 70.

## VALLEY OAK ROOM

Located just outside the city lights, The Valley Oak Room provides a beautiful reception space for up to 150 guests. Surrounded by an attached patio overlooking the panoramic golf course, guests can choose to be inside or enjoy the countryside on the balcony.



Also offered is an on-course Grand Oak Ceremony Venue for rustic outdoor wedding ceremonies.

The Valley Oak Room is open to both members and non-members.
